2. The organizers reserve the right to cancel / withheld, re-allot of the stalls in case of any payment disputes.

3. The organizers reserve the right to change the layout/size/zone of the stalls as in part of adjustments, if necessary

4. The stall allotment will be on first come first serve basis.

5. Participation: Application for participation is to be made in the prescribed form. Acceptance of participation and exhibits will be at the sole discretion of the organizers.

6. Stall Possession:

Bare Space 5<sup>th</sup> February 2019 at 10.00 am

Shell Scheme: 6<sup>th</sup> February 2019 at 10.00 am

7. Electricity charges: Available at 230 Volts/1 phase and 400Volts. 3phase A.C 50 Cycles. Charges as Additional requirement per KW Chargeable Basis. Additionally request for power connection should be made along with payment one month prior to the commencement of the event.

8. Vacation of space: Exhibition space will have to be vacated before 6 am on 10<sup>th</sup> February. 2019 falling which participants will be required to pay penalty as prescribed by the authorities.

9. Security: The organizers will make the general security arrangement; however, participants will be responsible for the security of the exhibits and stall. They can make security arrangements of their stalls.

10. Cancellation: No refund of advance paid will be made after signing the space application form and advance payment of 50% received. Any cancellation on or after November 2018, will attract complete payment of the participation charges due. In case of non-compliance, legal action will be initiated.

11. Payment Schedule: Advance booking-40%

By 15th September 2018 -30%

By 15th December 2018-30%

12. Handling of Exhibit, Customs and Import: Services for handling, Clearing and forwarding would be available at the Exhibition Ground at Extra Cost.

13. Display of Banners/placards, high volume of sound with speakers which interfere with other exhibitors in the premises is not permitted.

14. The exhibitor may distribute only literature and samples and shall not sell any products at the stall.

15. The organizers reserve the right to reschedule the event in the interest of the exhibition, if due to unavoidable circumstances which are beyond the reason and control of the organizers.

16. Insurance: The organizers will not be responsible for any loss, what so ever, incurred by the Exhibitors. They may obtain comprehensive insurance coverage for their exhibits against all risks for the periods covering transportation, preparation, exhibition, dismantling, return and transit.

17. Fire prevention: Participants will keep and maintain firefighting equipment with in their stalls as per safety regulations.
